

This statement provides you with information regarding the policies I have established and follow by which I protect the privacy and integrity of the information I collect.

This statement describes:

Who I am. I am Kenn Ellner. I rent out my condo for vacation rental services via my website www.mauivacation1.com.

What information I collect via my Web Site(s), and how the information is collected.

How I use and protect the information I collect.

What choices are available to you regarding collection, use, and distribution of the information.

How you can correct any inaccuracies in the information.

Information I Collect

I provide vacation rental services of my condo in Kahana, Maui Hawaii. I will not sell, share, or rent this information to others in ways different from what is disclosed within this statement and within any agreements with my customers.

My customers are usually individuals. Therefore, most of the information I receive and collect is of a personal nature.

Regardless of the nature of the information and regardless of whether it is information I solicit directly from my customers, and from visitors to my Web site or whether I collect the information during the processing of visiting the sites, I regard all such information as private and take steps to protect the integrity and confidentiality of the information.

Commitment to Security, Privacy, and Standards

I take seriously my responsibility to protect the security and

privacy of the information I receive and maintain. I continue to review my policies and procedures to assure that they are appropriate and effective in meeting my commitments to my community, my customers, and me.

Any suspected attempt to breach these policies and procedures or to engage in any type of unauthorized action involving this Web site is regarded as potential criminal activity and all suspected computer mischief will be reported to the appropriate authorities.

Use of Personal Information

Information collected regarding visitors to my Web site will be used by me only as appropriate to provide authorized services or to communicate information regarding those services. No information regarding specific persons, including my customers, my contractors or employees, or visitors to my Web site, will be provided to any non-affiliated organization, except as may be legally required, to prevent fraud, or to comply with the legal inquiry of the government. This policy does not preclude my unrestricted use of non-personal, summarized, derived, or aggregate information (i.e., volumes, totals, averages, etc.).

Customer Options

I do not anticipate a change in my policies regarding the use of personal information (see section above, Use of Personal Information). However, should I at some future time, change my practices regarding the use of personal information (i.e., to share such information with third parties) my customers will be provided an opportunity to choose to be excluded from any such use of public or non-public personal information prior to their information being used for such purposes. You have a choice, where and what you want to be viewed, and you have the option of providing your personal information to my Web Site and link sites.

Changes to Information Security and Privacy Statement

I continue to adhere to good business practices. I will regularly

review my policies and practices as it determines them to be warranted. When changes are made that affect the Information Security and Privacy Statement, these changes will be posted to my Web site.

Information Collected via My Web Site

I solicit, collect, or retain public or non-public personal information regarding customers or visitors to my Internet site, only as may be required to allow me to respond to requests for information about my products and services. The only information obtained about a visitor to my Web site is information that is voluntarily supplied by that visitor. Information about my customers and visitors to my Web sites, regardless of whether acquired via my Web site, or through other means, it is not shared with affiliated or non-affiliated entities.

Cookies

My site(s) may create a file or cookie on the hard drive of your computer in order to retain information that is used by my Web site. These files are used during your online session to ensure access to my site is authorized and to control certain parameters of your communication session with my site. I do not use these files to monitor the behavior of visitors to my site. Sponsors and advertisers may also use cookies if you choose to visit their advertisement. Information regarding their use of cookies should be obtained directly from those providers.

IP Addresses

An IP address is a number assigned to your computer for accessing the Internet. All computer identification on the Internet is conducted using IP addresses, to allow other computers and servers to recognize and communicate with each other. If a visitor requests pages from my site(s) or my affiliate site(s), the servers enter the visitor's IP address into a log. I do not associate IP addresses with personal information received from visitors.

I make no representation regarding your use of such web sites.
